ON 12-19-96, I ARRANGED AND CONDUCTED A LIVE LINEUP AT THE MARICOPA COUNTY 1ST AVENUE JAIL, WHICH IS LOCATED AT 102 WEST MADISON STREET.

AT 1000 HOURS I WAS ESCORTED THROUGH THE 1ST AVENUE JAIL TRUSTEE TANK WHERE I SELECTED INMATES #1 THROUGH #4 AND #6 AND ASKED THEM IF THEY WANTED TO VOLUNTEER TO PARTICIPATE IN THIS LIVE LINEUP PROCEDURE. ALL VOLUNTEERED AND WERE PROVIDED WITH IDENTICAL BLUE BIO-HAZARD PROTECTIVE JUMPSUITS. JAMES C. HARROD WAS BROUGHT TO THE SAME AREA AND ALSO GIVEN A MATCHING JUMPSUIT.

ALL FIVE INMATES SELECTED WERE SIMILAR APPEARING WHITE MALES WITH BROWN HAIR, AND MUSTACHES WHICH MATCHED JAMES HARROD'S APPEARANCE ON DECEMBER 19, 1966.

DEBBIE LUSTER WAS BROUGHT TO THE JAIL BY COUNTY ATTORNEY PARALEGAL DICK STROEBEL WHO HAD BEEN INSTRUCTED NOT TO DISCUSS THIS PROCEDURE WITH HER. AT 1117 HOURS WHILE ON VIDEO TAPE, WHICH WAS MADE BY JOHN SWORDS FROM THE COUNTY ATTORNEY'S OFFICE, DEBBIE LUSTER WAS READ A LIVE LINEUP ADVISEMENT BY MYSELF, TO WHICH SHE REPLIED "YES" TO UNDERSTANDING THE ADVISEMENT. THE ADVISEMENT GIVEN IS AS FOLLOWS.

DEBBIE WAS THEN BROUGHT INTO A VIEWING ROOM INSIDE THE JAIL WHERE SHE COULD OBSERVE THE SIX INDIVIDUALS THROUGH ONE WAY GLASS.

DURING HER OBSERVING SHE ASKED TO HAVE THE SUBJECTS WALK, MOVE CLOSER TO THE GLASS INDIVIDUALLY AND ALSO TO HAVE THEM SPEAK. SHE ASKED TO HAVE INMATES #2 AND #5 (HARROD) MOVE CLOSE TO THE GLASS FOR CLOSER OBSERVATION. SHE ADVISED ME THAT INMATE #5 LOOKED FAMILIAR.

AFTER APPROXIMATELY FIFTEEN MINUTES SHE SAID SHE WAS FINISHED AND THE INMATES WERE ALLOWED TO LEAVE THE VIEWING AREA. DEBBIE THEN ADVISED ME THAT INMATE #5 APPEARED TO BE THE SAME MAN WHO SHE KNEW AS GORDON PHILLIPS FROM WHEN SHE MET HIM ALMOST TEN YEARS AGO. SHE RECOGNIZED HIM FROM HIS APPEARANCE AND HIS VOICE.
